### **AC 18.7 To consider and approve the PPR (Programme project report) for Online Programs**

The University is undergoing NAAC Accreditation process. To plan in advance the Management has decided to initiate the preparation of PPR for permission to submit application to DEB, UGC for following four programmes:

1. Bachelor of Business Administration (FYUG)
2. Bachelor of Computer Applications (FYUG)
3. Master of Business Administration
4. Master of Computer Applications

It was decided to take consent of Academic council to go ahead for advance preparation so that application can be submitted as soon as the University get the accreditation of NAAC.


The Academic Council deliberated on the Programme project report (PPR) submitted for the launch of Online Programmes in Management and Computer Science at Usha Martin University. The PPR, for MBA, BBA, MCA and BCA prepared in accordance with the guidelines of the University Grants Commission (UGC) and other relevant statutory bodies, were reviewed in detail. The Council noted that the report comprehensively covers all aspects of programme design and delivery, including curriculum design, learning outcomes, faculty qualifications, instructional design, learner support, and infrastructure readiness for online delivery.

After thorough discussion, the Academic Council approved the Programme project report for the proposed Online Programmes, subject to compliance with all regulatory requirements and subsequent approvals from the competent authorities. The Academic Council also suggested to initiate the process of SLM under the supervision of Director , CDOE .

### **AC18.8 To consider and approve the important norms for Online Programs**

The Academic Council discussed and approved the following important norms for Online Programmes.

1. Nomenclature of the offered programmes as per the specification of degrees in conventional mode
