  - c) in case the consent of affiliation of Examining Authority is not obtained and submitted to PCI before making admissions, the above approval granted by the PCI shall be deemed to be withdrawn and consequences thereof shall rest on the institution and the PCI in no way shall be responsible for the same.
  
- **Regarding B.Pharm course**, it was further decided that -
